Client Information and Release Forms

Release

Photography services will not begin until the client release and information forms have been read, understood, and signed by adult parties utilizing the services.

Payment

For client convenience and security, Joseph N. Dassaro [Dassaro Imaging] accepts payment via PayPal and through the Dassaro.com site. Via PayPal, you are able to pay using debit, credit card, Bill Me Later, or your PayPal Balance. You do not need a PayPal account.

Edited Images

Depending on your session a number of images will be selected for edit. Images are selected based on clarity, facial expression, general feel, etc. If, after viewing your gallery, there are images you specifically want to have edited in addition to those already selected by the photographer, a separate editing fee will apply. Under no circumstances do I release unedited images for viewing. In some rare cases when photographing young children they may have an "off" day. If the photographer believes enough quality images did not turn out, the client will receive a voucher for a free mini session. This is at the photographer's discretion.

Print minimum

Joe Dassaro [Dassaro Imaging] does not require a print minimum. Print orders of any size and cost may be sent to the print lab.

Shipping

Shipping costs are determined by print order on the Dassaro.com website. Orders typically arrive within 3 business days.

Time frames

In times of high volume your previews may be posted to the Dassaro Imaging Facebook Fan Page (facebook.dassaro.com) within 7 days after your session, and your gallery will be ready 10-15 days after your session. During off-peak times, you may see that reduced by 50% or more. You may tag images directly on facebook and share accordingly. Please do not remove the watermark from images. The watermark is not to discourage you from sharing, but to protect my work from other photographers. Client galleries are available for one year from the shoot date or the most recent print order date and are extended for one year upon every print order over \$50. If your gallery expires there is a \$25.00 re-listing fee to re-list it for an additional 6 months.

Weather

In times of inclement weather the shoot will be re-scheduled at no additional fee. If you feel it is unsafe for you to drive, please let me know. Your safety is my concern.

Out of area travel

I will shoot within 20 miles of zip code 37128. Travel outside that radius for sessions will include a per-mileage rate as well as additional charges if they apply (parking, entrance to preferred area, etc.) Travel fee's may vary on gas rates, please speak with Joe Dassaro to verify current pricing. An invoice for out of area travel will be sent via paypal before the session begins. Currently, Nashville locations are an additional \$25.

Photo Release for Adults and Minors

This authorization and release shall inure to the benefit of the legal representatives, licensees and assigns of the photographer as well as the person(s) for whom he/they took the photographs.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law in effect on the date this document was signed.
